- ♣ Deposit is non-refundable if cancelled by party member, 2 week cancellation notice preferred **x** _____
- ♣ Refunds will be issued by the Recreation Dept. if canceled due to incimate weather
- ♣ Sufficient parental supervision is required based on the number of students and/or children that are attending **x** _____
- ♣ If the pool is closed due to incimate weather, during regular pool hours, the splash party will be rescheduled or refunded **x** _____
- ♣ Renter must leave the facility in good clean condition **x** _____
- ♣ Rental time is 9:10 p.m. until 10:40 p.m. (*All patrons must exist facility by 10:50 p.m.*)-hrs. Subject to change **x** _____
- ♣ Participants must exit pool upon employees' request
- ♣ **No alcoholic beverages permitted** **x** _____
- ♣ **This is a smoke-free facility** **x** _____
- ♣ Concession Stand will not remain open and guests are welcome to bring their own food (*must remain by concession area*). *Must keep ALL FOOD & BEVERAGE in concession area, no food/beverage on pool deck* **x** _____
- ♣ No glass containers
- ♣ Proper swim attire is required
- ♣ Contact person is responsible for reading, signing and understanding the agreement
- ♣ No radios, crock pots, or other gas/electrical devices permitted due to safety regulations
- ♣ If rules are not followed consistently and there is excessive clean-up for the staff, deposit will not be returned (Manager's discretion) **x** _____
- ♣ **NO TRAINS ON SLIDES, MUST BE 48 INCHES AND A STRONG SWIMMER FOR BOTH SLIDE/DIVING** **x** _____
- ♣ In the event that the above policies are not followed, the Bay Village Recreation Department has the right to revoke SPLASH Party privileges and/or Pool usage for the future **x** _____
- ♣ General pool guidelines/rules apply to all splash parties, all guidelines are subject to change if management deems necessary, please see attached rules -please review and sign **x** _____
- ♣ Management reserves the right to end party early if rules/guidelines are not followed **x** _____
